**AMENDED AND RESTATED CERTIFICATE OF FORMATION
OF
HUISH DIVERS, LLC**

This Amended and Restated Certificate of Formation of Huish Divers, LLC (the "Company"), dated as of September 13, 2011, has been duly executed and is being filed by the undersigned, as an authorized person, in accordance with the provisions of 6 Del. C §18-208, to amend and restate the original Certificate of Formation of the Company, which was filed in the office of the Secretary of State of the State of Delaware (the "Secretary of State") on January 3, 2011 (the "Certificate"), under the Delaware Limited Liability Company Act (6 Del. C §18-101, et seq.).

The Certificate is hereby amended and restated in its entirety to read as follows:

1. The name of the limited liability company is Atomic Aquatics, LLC.
2. The registered office of the Company in the State of Delaware is located at 160 Greentree Drive, Suite 101, in the City of Dover, County of Kent, Delaware 19904. The Company's registered agent at such address is National Registered Agents, Inc.
3. To the fullest extent the Delaware Limited Liability Company Act, as it exists on the date hereof or may hereafter be amended, permits the limitation or elimination of liability of members, a member shall not be liable to the Company or the other members for monetary damages for conduct as a member. Any amendment to or repeal of this Section 3 shall not adversely affect any right or protection of a member for or with respect to any acts or omissions of such member occurring prior to such amendment or repeal.

This Amended and Restated Certificate of Formation shall be effective as of the date of filing with the Secretary of State.
