The Assignor hereby authorizes and requests the Commissioner of Patents of the United States to issue, record and memorialize this Assignment with regard to all of the Assigned Patents; and the Assignor hereby authorizes and requests all foreign national governments and authorities that have issued the Assignment Patents to issue, record and memorialize this Assignment with regard to all of the Assigned Patents.
