(The above-mentioned patent(s)/application(s) as a whole hereinafter referred to as the IP ASSET)



4. ASSIGNOR assigns no rights to Assignee other than those transferred hereunder, and Assignor retains any and all right, title and interest any patents, copyrights or intellectual property of any kind not expressly conveyed herein.
