

Pursuant to the General Corporation Law of the State of Delaware (the "DGCL"), Brown's River Marotti Co., a Delaware corporation ("BRM"), and Louisiana Binding Service, Inc., a Texas corporation ("LBS"), have adopted the following Certificate of Merger (the "Certificate"):

FIRST: The names of the entities participating in the Merger and the states under the laws of which they are incorporated or organized are as follows:

SECOND: An Agreement and Plan of Merger, dated as of August 29, 2011 (the "Merger Agreement"), has been approved, adopted, certified, executed, and acknowledged by the merging constituent corporations in accordance with the DGCL and the laws of the State of Texas.

THIRD: The name of the surviving corporation is Brown's River Marotti Co., a Delaware corporation (the "Surviving Corporation").

FOURTH: The Certificate of Incorporation of BRM shall be the Certificate of Incorporation of the Surviving Corporation.

FIFTH: Article First of the Certificate of Incorporation of the Surviving Corporation is hereby amended to read in its entirety as follows:

"FIRST: The name of the Corporation is Kofile Preservation, Inc."

SIXTH: A copy of the executed Merger Agreement is on file at the principal place of business of the Surviving Corporation, which is located at 6300 Cedar Springs Road, Dallas, Texas, 75235.


SEVENTH: A copy of the Merger Agreement will be furnished by the Surviving Corporation, on request and without cost, to any stockholder of the constituent corporations.

EIGHTH: The delayed effective time of the Certificate is 12:01 a.m. on September 1, 2011.
