

AND I HEREBY covenant that I have full right to convey the entire interest herein assigned, that I have not copied or used information that may be subject to a trade secret owned or under the control of a third party, and that I have not executed, and will not execute, any agreement in conflict herewith.

AND I HEREBY further covenant and agree that I and my heirs, representatives and successors, if any, will communicate to said **TetraSun, Inc.**, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and/or declarations, and generally do everything possible to aid said **TetraSun, Inc.**, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.

AND I HEREBY grant Heslin Rothenberg Farley & Mesiti P.C., the power to insert on this Assignment any further indication that may be necessary or desirable in order to comply with the Rules of the United States Patent and Trademark Office for recordation of this document.


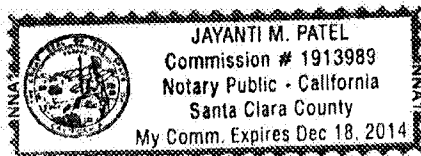
