ASSIGNMENT

THIS ASSIGNMENT is made BETWEEN

**Russell John Trinick** of 3 Uwch Y Dre, Gwernymynydd, Mold, Flintshire, CH7 4AB, United Kingdom (hereinafter called "the Assignor");

AND

**Henrob Limited** of Second Avenue, Zone 2, Deeside Industrial Park, Flintshire, CH5 2NX, United Kingdom (hereinafter called "the Assignee").

WHEREAS

(A) The Assignor is the inventor of an invention relating to **SELF-PIERCING RIVETING** (hereinafter referred to as "the Invention") which is the subject of an International Patent Application No. **PCT/GB2007/001725** filed on **10 May 2007** and designating amongst other countries the United States of America (hereinafter referred to as "the Application")

(B) The Assignor is the applicant for the Application in so far as it relates to the United States of America

(C) The parties hereto have agreed that all the Assignor's rights in the Invention and the Application and rights ancillary thereto should be transferred by the Assignor to the Assignee for the consideration hereinafter set forth.

In consideration of the sum of £1 paid by the Assignee to the Assignor (the receipt of whereof is hereby acknowledged) the Assignor hereby assigns to the Assignee with full title guarantee all the Assignor's right, title and interest in the Invention and the Application insofar as it relates to the United States of America, and all the rights, powers, liberties and immunities conferred on the proprietor thereof by the grant of Patents thereon free from all incumbrances, including the right to sue for damages or other remedies in respect of any infringement of such rights prior to the date hereof TO HOLD unto the Assignee absolutely.

2. The Assignor agrees to execute all papers and documents necessary in connection with the Application or any interference which may be declared and any continuing or divisional applications thereof and also to execute separate assignments in connection with such applications as the Assignee may deem necessary or expedient and further to perform any act which may be necessary in connection with claims or provisions of the International Convention for Protection of Industrial Property or similar agreements.

3. The Assignor agrees to perform all affirmative acts which may be necessary to obtain a grant of a valid United States patent to the Assignee.

4. The Assignor hereby authorizes and requests the Commissioner of Patents to issue any and all Letters Patent of the United States resulting from the Application or any division or divisions or continuing applications thereof to the Assignee, as Assignee of the entire interest, and hereby covenants that he has full right to convey the entire interest herein assigned and that he has not executed and will not execute any agreement in conflict herewith.

5. The Assignor hereby grants the firm of MARKS & CLERK the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent Office for recordation of this document
