
PATENT ASSIGNMENT

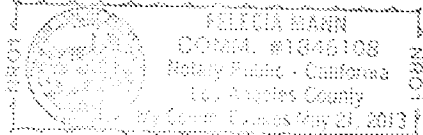
