AND I, on behalf of the Estate of von Phul, hereby covenant and agree that I will at any time upon the request and at the expense of D-Foam, Incorporated, execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect title to said invention and the Patents therefore, and I hereby authorize and request the United States Patent and Trademark Office and the Canadian Intellectual Property Office to recognize D-Foam, Incorporated as the owner of said Patents.

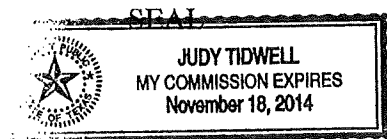

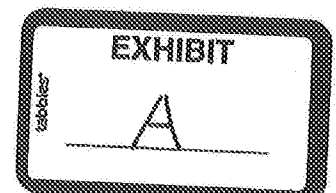
