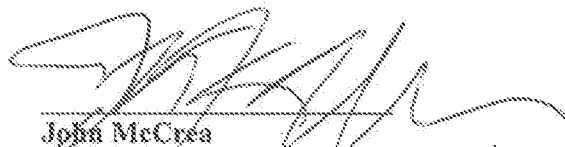

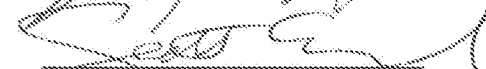

granted, as fully and entirely as the same would have been held and enjoyed by the undersigned if this assignment had not been made.

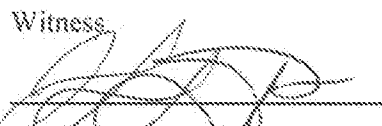
