PATENT ASSIGNMENT

This Assignment is made as of November 23, 2011 by and between Axxom Software AG, ("Assignor"), a German corporation having an address of Paul-Gerhardt-Allee 46, 81245 Munich, Germany and PSI Logistics GmbH ("Assignee"), a German limited liability company having an address of Dircksenstrasse 42-44, 10178 Berlin, Germany.

WHEREAS, Assignor and Assignee are parties to a Sales Contract dated September 1, 2011 in which Assignor sells and/or agrees to sell to Assignee certain Intellectual Property including, without limitation, U.S. Patent No. 7,369,910 entitled "Method for the Optimizing of a Production Process," issued on May 6, 2008 and filed on November 10, 2003 as U.S. Application Serial No. 10/704,877.

2. FURTHER ASSISTANCE.

Assignor hereby covenants and agrees that the Assignor will at any time upon the reasonable request and at the expense of the Assignee execute and deliver any and all papers and do all lawful acts that may be necessary or desirable to perfect the rights, titles, and interests conveyed to Assignee herein and Assignee's successors and assigns and to permit Assignee and Assignee's successors and assigns to record this Assignment against the Intellectual Property listed on Schedule A attached hereto with any government office.
