WHEREAS, I, Bryan Eugene RABELER, resident of 1214 Limestone Creek Dr., Keller, TX 76248, citizen of the United States, have invented certain new and useful improvements in a "APPARATUS AND METHOD FOR FAULT TOLERANT FOTA UPDATE" disclosed in an application for United States Letters Patent (Application No. 13/307,230), filed November 30, 2011), said application having been executed concurrently herewith;

WHEREAS, SAMSUNG ELECTRONICS CO., LTD, a corporation organized under the laws of the Republic of Korea, having a place of business at 416, Maetan-dong, Yeongtong-gu, Suwon-si, Gyeonggi-do 442-370, Republic of Korea (hereinafter referred to as "ASSIGNEE"), is desirous of acquiring our entire right, title and interest in and to the invention, and in and to the said application and any Letters Patent that may issue thereon;
