## ASSIGNMENT

The undersigned inventor(s) (hereinafter "Assignor") of the residence(s) indicated below has/have invented an ELECTRODE SYSTEM WITH IN-BAND IMPEDANCE DETECTION (hereinafter the "Invention").
