ASSIGNMENT


WHEREAS, We, Robert D. Glaser, a United States citizen, residing at 737 Lake Washington Boulevard, Seattle, WA 98122, Mark O'Brien, A United States citizen, residing at 27 Trowbridge, No. 2, Cambridge, MA 02138, Thomas B. Boutell, a United States citizen, residing at 426 Bellevue Avenue East, Apt. 1, Seattle, WA 98102, and Randy Glen Goldberg, a United States citizen, residing at 48 Primrose Circle, Princeton, NJ 08540, have invented certain new and useful improvements in a AUDIO ON DEMAND SYSTEM for which we have executed an application for Letters Patent in the United States, on even date herewith;

AND WE HEREBY covenant and agree that we will communicate to the said Progressive Networks, its successors, legal representatives and assigns, any facts known to us respecting said improvements, and testify in any legal proceeding, sign all lawful papers, execute all divisional, continuing and reissue applications, make all rightful oaths and generally do everything possible to aid the said Progressive Networks, its successors, legal representatives and assigns, to obtain and enforce proper patent protection for said improvements in all countries.
