(2) in and to said United States patent application, in and to all other patent applications (including divisional, continuation, continuation-in-part, §111(b) provisional, §111(a), reissue applications, and international patent applications designating the United States) based upon said invention, and in and to the patent or patents to be granted thereon,

including reissues thereof, if any, to the full end of the term or terms for which said patent or patents may be granted; and

(3) in and to all patent applications on said invention now or hereafter filed in countries foreign to the United States of America, including patent applications filed under the Patent Cooperation Treaty, the European Patent Convention or any other international treaty, and including the right to claim priority of said United States application, and in and to any and all patents granted on said applications to the full end of the terms for which said patents may be granted.

The foregoing notwithstanding, and in recognition of the fact that Assignee is part of the Bosch group of companies, we hereby assign to Robert Bosch GmbH, a German corporation having a mailing address at Postfach 30 02 20, D-70442 Stuttgart, GERMANY, the limited right to be named as assignee or applicant at the time of publication and at the time of issue on any applications or patents granted as referred to in foregoing paragraphs (2) and (3). If the right applicable to any such patent application allows an assignee to be the applicant of the patent application, Robert Bosch GmbH shall have the right to be identified as applicant of the patent application and the right to claim priority of said United States application. This limited right granted to Robert Bosch GmbH with respect to any patent application or granted patent shall expire upon the first-occurring of (i) assignment to a third

party of any of the above-mentioned rights of Assignee, or (ii) with respect to any particular patent, issue of such patent, and shall be subsequently part of the assignable rights of Assignee. All other rights to said invention, said applications and said patents, U.S. or foreign, including the right under any of said patents to manufacture, use, sell or offer for sale the invention covered by said patents, or to license or permit use of said invention, remain with Assignee and shall be assignable by Assignee without the consent of Robert Bosch GmbH.


