ASSIGNMENT

WHEREAS, I, Carsten Glasenapp, of Sperberstrasse 12, 73447 Oberkochen, Germany, have invented certain new and useful improvements in OPTICAL APPARATUS FOR NON-CONTACT MEASUREMENT OR TESTING OF A BODY SURFACE, for which an application for Letters Patent of the United States is being made, and which may be identified in the United States Patent Office by Application No. 13/132,808, filed June 3, 2011.

countries on said invention, and in enforcing any rights occurring as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents.
