**RECORDABLE CONFIRMATORY ASSIGNMENT**

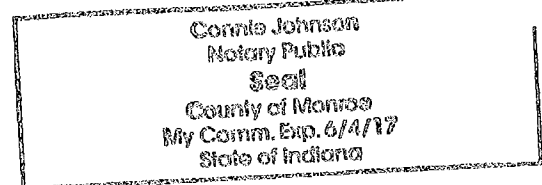

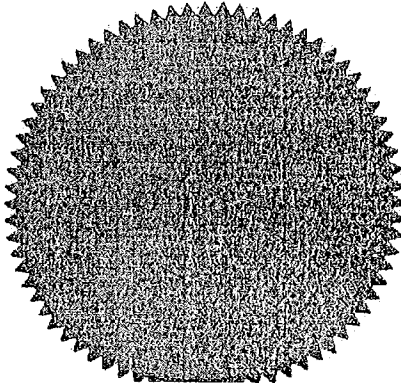
