## ASSIGNMENT AND ASSUMPTION AGREEMENT

This ASSIGNMENT AND ASSUMPTION AGREEMENT (this "<u>Assignment</u>") is made effective as of May 19, 2009, by and between Third Brigade Inc., a federal Canada corporation (the "<u>Assignor</u>"), and Trend Micro Kabushiki Kaisha, a Japan corporation ("<u>Assignee</u>"), pursuant to that certain Asset Purchase Agreement dated as of April 28, 2009 (the "<u>Asset Purchase Agreement</u>"). All capitalized terms not otherwise defined herein shall have the meaning ascribed to such term in the Asset Purchase Agreement.

## RECITAL

In connection with the transactions contemplated under the Asset Purchase Agreement, the Assignor desires to assign all right, title, and interest in and to the Third Brigade Intellectual Property to Assignee.

#### AGREEMENT

NOW THEREFORE, in consideration of the mutual covenants contained herein and other good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Assignor and Assignee agree as follows:

1. <u>Sale of Third Brigade Intellectual Property</u>. In consideration of payment by assignee of that portion of the Purchase Price allocated to the Third Brigade Intellectual Property, Assignor does hereby sell, convey, assign, transfer, and deliver to Assignee, its successors and assigns, free and clear of all encumbrances all of the Third Brigade Intellectual Property and all goodwill associated therewith.

2. <u>Patents and Trademarks</u>. The Assignor covenants and agrees to execute and deliver a patent assignment to be filed with the applicable patent and trademark offices, in substantially the form of Patent Assignment attached hereto as <u>Exhibit A</u>. The Assignor further covenants and agrees to execute and deliver a trademark assignment to be filed with the applicable patent and trademark offices, in substantially the form of Trademark Assignment attached hereto as <u>Exhibit B</u>.

3. <u>Further Assurances</u>. Assignor covenants and agrees with the Assignee that the Assignor will, from time to time and at all times hereafter, upon the reasonable request and at the expense of the Assignee, do and cause to be made, done, and executed all such further acts, deeds or assurances as may be reasonably requested of the Assignor to more effectually and completely vest in the Assignee, its successors and assigns, worldwide rights to the Third Brigade Intellectual Property hereby transferred, assigned and set over in accordance with the terms hereof or the Asset Purchase Agreement.

Assignor hereby irrevocably nominates, constitutes and appoints Assignee as the true and lawful attorney-in-fact of Assignor (with full power of substitution) effective as of the date hereof, and hereby authorizes Assignee, in name of and on behalf of Assignor, on or after the date hereof, to execute, deliver, acknowledge, certify file, and record any document, to institute and prosecute and proceeding and to take any other action that Assignee may deem appropriate for the purpose of carrying out or facilitating any of the above transactions. The power of attorney referred to in the preceding sentence is and shall be coupled with an interest and shall be irrevocable, and shall survive the dissolution or insolvency of the Assignor.

5. <u>Successor and Assigns</u>. This Assignment shall be binding upon and inure to the benefits of the Assignor and the Assignee and their respective successors and assigns.

6. <u>Multiple Counterparts</u>. This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument. Facsimile signature pages shall be considered originals.
