MUTUAL RELEASE AND FINAL SETTLEMENT AGREEMENT

THIS MUTUAL RELEASE AND FINAL SETTLEMENT AGREEMENT (this "Agreement") is made and entered into by and among STEPHEN D. BARNHILL, M.D. ("Dr. Barnhill"), AMY J. BARNHILL ("Mrs. Barnhill"), JULES PADEREWSKI, DDS ("Dr. Paderewski"), JOSEPH MCKENZIE, DVM ("Dr. McKenzie"), JAMES TOBEY ROBERTS ("Mr. Roberts"), MEMORIAL HEALTH TRUST, INC., a Georgia nonprofit corporation ("Memorial"), CURTIS ANDERSON ("Mr. Anderson"), HEALTH DISCOVERY CORPORATION, a Texas corporation ("HDC"), GARRY CARLS, M.D. ("Dr. Carls"), TIMOTHY P. O'HAYER ("Mr. O'Hayer"), JOHN E. MATTHEWS, CPA ("Mr. Matthews"), GLYNN A. BERGERON, M.D. ("Dr. Bergeron"), JULIAN STERN, ESQ. ("Mr. Stern"), ANTHONY BARNES, PH.D. M.B.A. ("Mr. Barnes"), K. RUSSELL SIMPSON, ESQ. ("Mr. Simpson"), and BBFMO, LLC, a Georgia limited liability company ("BBFMO"). As used hereinafter, "Party" means any of the above-listed individuals and entities who execute this Agreement on or before May 20, 2005, and "Parties" means all of the above-listed individuals and entities. "Third Person" means any individual or entity other than the Parties.

RECITALS:

A. Numerous disputes exist between the Parties, including but not limited to matters relating to the formation and operation of BBFMO and the formation, funding (debt and equity), management and bankruptcy of Barnhill Genomics, Inc., a Delaware corporation ("Genomics") and

BiOwulf Technologies, LLC, a Georgia limited liability company ("Technologies") and predecessor entities which were merged into Genomics or Technologies. Genomics, Technologies and all such predecessors hereinafter collectively are referred to as the "Companies".

G. On the terms and conditions hereinafter set forth, the Parties desire to settle their claims and enter into mutual releases.

NOW, THEREFORE, for and in consideration of the premises and other good and valid considerations, the receipt and sufficiency of which are acknowledged by each of the Parties, the Parties agree as follows intending to be legally bound hereby:

1. The recitals set forth above are true and are incorporated herein by reference.


B. Upon receipt of the \$175,661.83 for BBFMO (and any additional funds from Dr. Bergeron and Mr. Matthews), Mr. Bulovic promptly shall transmit all of such amount to SunTrust Bank in full and final satisfaction of the SunTrust Suit. By execution of this Agreement, each member of BBMFO authorizes Todd Wade, Esq., as counsel to HDC, to cancel, release, terminate and otherwise extinguish any UCC-1 or other instrument filed by or on behalf of BBMFO purporting to secure an interest in any prior or existing asset of Genomics or Technologies.



This Agreement shall become effective upon the execution by all of Dr. Barnhill, Mrs. Barnhill, Dr. Paderewski, Dr. McKenzie, Mr. Roberts, Memorial, Mr. Anderson, HDC, Mr. Carls, Mr. O'Hayer, Mr. Matthews, Dr. Bergeron, Dr. Barnes, Mr. Simpson and BBMFO, the date of which final execution shall be the date of this Agreement; provided, however, that any other party may execute and otherwise become a Party to this Agreement by executing this Agreement on or before May 20, 2005. This Agreement shall be binding only on those Parties who actually execute this Agreement on or before May 20, 2005, and no party who fails to so execute this Agreement shall be deemed to be a third-party beneficiary of, or have any right to enforce, any provision of this Agreement.


