**ASSIGNMENT OF UNITED STATES PATENT APPLICATION**

WHEREAS, I, **Andrew Colley of Flat 16 Braehead, Methven Walk, Dundee DD2 3FJ, Scotland, United Kingdom** (hereinafter called "the inventor(s)"), have invented certain new and useful improvements in '**MEDIA DISPENSING**', **Docket No. DN11-000504.00** (hereinafter called "the invention"), for which I have executed an application for Letters Patent of the United States of America (hereinafter called "the application") on same date herewith, respectively; and

NOW, THEREFORE, to all whom it may concern be it known that I, the inventor(s), confirm the ownership by NCR Financial Solutions Group Limited of the invention and the application by operation of law under the United Kingdom Patents Act 1977 and if, under the law of the United States, or any other countries in the world, I the inventor(s) have any ownership right, title, and interest in the invention and the application (which I do not believe to be the case and claim no ownership right, title, or interest in the invention and the application based on the law of the United Kingdom), in consideration of the sum of One Dollar (\$1.00) and of other valuable considerations, the receipt of which is hereby acknowledged, I, the inventor(s), nevertheless hereby assign and transfer such ownership right, title, and interest in and to the invention and application to NCR Financial Solutions Group Limited, its successors and assigns. NCR Financial Solutions Group Limited in turn hereby assigns and transfers to NCR Corporation, its successors and assigns, the entire right, title, and interest in and to the invention and the application (including any right to claim priority under the International Convention), and in and to any divisions, continuations, reissues, and extensions thereof.

FURTHER, I, the inventor(s), and NCR Financial Solutions Group Limited hereby authorize and request any Letters Patent arising therefrom in the United States of America be issued to NCR Corporation, its successors and assigns.




