ARTICLES OF MERGER OF
CYTOGEL, INC. INTO
CYTOGEL SURVIVING ENTITY, LLC

Pursuant to the Section 33-819 of the Connecticut Business Corporation Act and Section 34-196 of the Connecticut Limited Liability Companies Act, the undersigned Connecticut Business Corporation and Connecticut Limited Liability Company executed the following Articles of Merger:

FIRST: The name of the surviving limited liability company is Cytogel Surviving Entity, LLC, a Connecticut Limited Liability Company, and the name of the corporation being merged into this surviving limited liability company is Cytogel, Inc. a Connecticut Corporation.

SECOND: The effective date of the Merger is as of the date of the filing of these Articles of Merger.

THIRD: The name of the surviving limited liability company is Cytogel Surviving Entity, LLC.

FORTH: The Plan of Merger has been duly authorized and approved by the surviving limited liability company in accordance with the provisions of section 34-194 of the Connecticut Limited Liability Company Act and has been duly authorized and approved by the shareholders of the corporation being merged into the surviving limited liability company in the manner required by sections 33-600 to 33-998 of the Connecticut Business Corporations Act, inclusive, and the Certificate of Incorporation

FIFTH: Pursuant to the Plan of Merger, the Articles of Organization of the surviving limited liability company shall be amended to change the name of the surviving limited liability company to Cytogel, LLC as of the effective date of the Merger.

SIXTH: The Plan of Merger is on file at 63 Locust Avenue, Suite 200, New Canaan, Connecticut, 06840, the place of business of the surviving limited liability company.

SEVENTH: A copy of the Plan of Merger will be furnished by the surviving limited liability company on request, without cost, to any person holding an interest in any limited liability company or corporation that is a party to the Merger
