AMENDED AND RESTATED
ARTICLES OF INCORPORATION OF
PACIFIC COAST WIRE ROPE & FITTINGS, INC.

The undersigned certify that:

1. They are the president and the secretary, respectively, of PACIFIC COAST WIRE ROPE & FITTINGS, INC., a California corporation.
2. The Articles of Incorporation of this corporation are amended and restated to read as follows:

I

The name of this corporation is **FEENEY, INC.**

II

The purpose of the corporation is to engage in any lawful act or activity for which a corporation may be organized under the General Corporation Law of California other than the banking business, the trust company business or the practice of a profession permitted to be incorporated by the California Corporations Code.

III

The liability of the directors of the corporation for monetary damages shall be eliminated to the fullest extent permissible under California law.

IV

This corporation is authorized to issue only one class of shares of stock, which shall be designated as "common" shares. The total number of shares which this corporation is authorized to issue is one hundred thousand (100,000).

V

The corporation's issued shares shall be held of record by not more than ten (10) persons. This corporation is a close corporation.

IV


The corporation is authorized to indemnify the directors and officers of the corporation to the fullest extent permissible under California law.


3. The foregoing amendment and restatement of Articles of Incorporation has been duly approved by the board of directors.

4. The foregoing amendment of Articles of Incorporation has been duly approved by the required vote of shareholders in accordance with Section 902, California Corporations Code. The total number of outstanding share of the corporation is 1250. The number of shares voting in favor of the amendment equaled or exceeded the vote required. The percentage vote required was more than 50%.

We further declare under penalty of perjury under the laws of the State of California that the matters set forth in this certificate are true and correct of our own knowledge.
