UNITED STATES PATENT NO. 6,748,263

This assignment is made on 2 December 2011 between

(1) The University of Bristol of Senate House, Tyndall Avenue, Bristol, BS8 1TH, United Kingdom (the 'Assignor')

and

(2) Alpha-Active Limited of 2 Devonshire Court, Heathpark, Honiton, Devon EX14 1SB, United Kingdom (the 'Assignee')

WHEREAS

The Assignor is the proprietor and beneficial owner of United States Patent No. 6,748,263. (the 'Patent').

If proceedings are instituted by way of claim, petition or counter claims impugning the validity of the Patent at any time, the Assignor shall give all reasonable assistance to the Assignee in relation to those proceedings (including participation in proceedings) subject to the payment by the Assignee of all the Assignor's reasonable costs in relation to those proceedings.

The assignment shall be governed by and construed in accordance with the laws of England and shall be subject to the exclusive jurisdiction of the courts of England.
