Assignment

WHEREAS, I, Bernd Schirmer, a citizen of Germany, reside at Rosellener Kirchstrasse 48; 41470 Neuss; Germany, and have made certain inventions or discoveries (or both) as set forth in an application for Letters Patent of the United States of America, entitled **Form**, bearing U.S. Patent Application No. 29/399,487 and filed on August 15, 2011;

WHEREAS, Bernd SCHIRMER, a citizen of Germany, whose address is Rosellener Kirchstrasse 48; 41470 Neuss; Germany, hereinafter referred to as SCHIRMER; and

WHEREAS, Christoffel Johannes SMIT a citizen of South Africa, whose address is 906 Deborah Street, Pretoria Gardens; 0089 Pretoria, South Africa, hereinafter referred to as SMIT;

and, together with their successors and assigns are desirous of acquiring the entire right, title and interest in the same;

NOW THEREFORE, for valuable consideration furnished by SCHIRMER and SMIT to me, receipt and sufficiency of which I hereby acknowledge, I hereby, without reservation:

1. Assign, transfer and convey to SCHIRMER and SMIT the entire right, title and interest in and to said inventions and discoveries, said application for Letters Patent of the United States of America, any and all other applications for Letters Patent on said inventions and discoveries in any and all countries, including all divisional, renewal, substitute, continuation and convention applications based in whole or in part upon said inventions or discoveries, or upon said applications, and any and all Letters Patent, reissues and extensions of Letters Patent granted for said inventions and discoveries or upon said applications, and every priority right that is or may be predicated upon or arise from said inventions, said discoveries, said applications and said Letters Patent;

2. Authorize SCHIRMER and SMIT to file patent applications in any or all countries on any or all of said inventions and discoveries in my name or in the name of SCHIRMER and SMIT or otherwise as SCHIRMER and SMIT may deem advisable, under the International Convention or otherwise;

3. Authorize and request the Commissioner of Patents of the United States of America and the empowered officials of all other governments to issue or transfer all said Letters Patents to SCHIRMER and SMIT, as assignees of the entire right, title and interest therein or otherwise as SCHIRMER and SMIT may direct;

4. Warrant that I have not knowingly conveyed to others any right in said inventions, discoveries, applications or patents or any license to use the same or to make, use or sell anything embodying or utilizing any of said inventions or

discoveries; and that I have good right to assign the same to SCHIRMER and SMIT without encumbrance;

5. Bind my heirs, legal representatives and assigns, as well as myself, to do, upon SCHIRMER and SMIT's request and at SCHIRMER and SMIT's expense, but without additional consideration to me or them, all acts reasonably serving to assure that said inventions and discoveries, said patent applications and said Letters Patent shall be held and enjoyed by SCHIRMER and SMIT as fully and entirely as the same could have been held and enjoyed by me, my heirs, legal representatives and assigns if this assignment had not been made; and particularly to execute and deliver to SCHIRMER and SMIT all lawful application documents, including petitions, specifications, and oaths, and all assignments, disclaimers, and lawful affidavits in form and substance as may be requested by SCHIRMER and SMIT; to communicate to SCHIRMER and SMIT all facts known to me relating to said inventions and discoveries or the history thereof; and to furnish SCHIRMER and SMIT with any and all documents, photographs, models, samples and other physical exhibits in my control or in the control of my heirs, legal representatives or assigns, which may be useful for establishing the facts of my conceptions, disclosures, and reduction to practice of said inventions and discoveries.
