

I hereby authorize and grant the right to **White Castle Management Co.** to file and prosecute patent applications in any or all countries on all or any part of said invention in my name or in the name of **White Castle Management Co.** or otherwise, as **White Castle Management Co., LLC** may deem advisable under any international convention, treaty, or agreement or otherwise.

I hereby request and authorize the Commissioner of Patents and Trademarks of the United States and the empowered officials of all other countries to grant, issue and transfer

any letters patent for said invention to **White Castle Management Co.**, as assignee of the entire right, title and interest therein, in accordance with this instrument of assignment.

I hereby represent and warrant that there are no outstanding rights or interest inconsistent with the rights and interests granted herein; I covenant that I will not execute, grant, or transfer any rights or interests inconsistent herewith; I bind myself and my heirs, executors, administrators and legal representatives to execute and deliver to **White Castle Management Co.**, and its successors and assigns, any further documents or instruments and to perform any and all further acts that may be deemed necessary to enable it, and its successors and assigns, to file applications for letters patent for said invention in any country in which it may elect to file such applications, and to vest in **White Castle Management Co.**, and its successors and assigns, the title herein conveyed and intended to so be, and to enable such title to be recorded in the United States and each foreign country in which each such application may be filed so that any patent issued thereon shall be issued to vest in **White Castle Management Co.**, and its successors and assigns; and I further covenant and agree that I will, upon request, communicate to **White Castle Management Co.**, and its successors and assigns, any facts relating to said invention and the history thereof, known to me and that I will testify as to the same in any proceeding, interference or litigation, when requested to do so by **White Castle Management Co.**, and its successors and assigns, with costs to be paid by **White Castle Management Co.**, and its successors and assigns.
