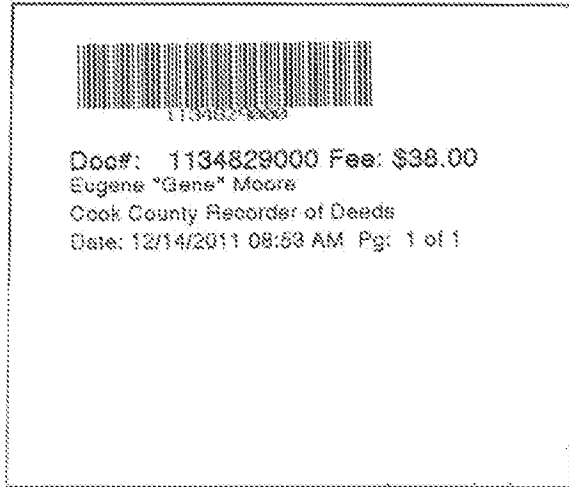



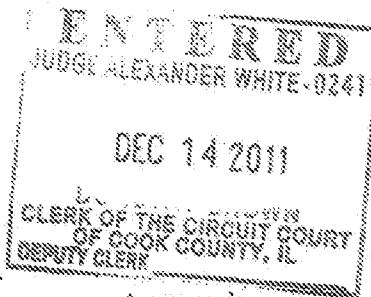

RELEASE (SATISFACTION) OF JUDGMENT


