**PATENT RELEASE**

THIS PATENT RELEASE AND REASSIGNMENT is made as of December 23, 2011 by **GENERAL ELECTRIC CAPITAL CORPORATION**, a Delaware corporation, as administrative agent (“**Agent**”).

WITNESSETH:

WHEREAS, Agent and **HOFFMASTER GROUP, INC.**, a Delaware corporation (“**Grantor**”), were parties to that certain Patent Security Agreement, dated as of June 2, 2010 (the “**Agreement**”), pursuant to which Grantor granted a security interest to Agent in certain patents (the “**Patents**”) and Patent Rights (as defined below) as security for certain obligations owing by Grantor to Agent, including the Patents set forth on Schedule 1 hereto; and

WHEREAS, the Agreement was recorded by the Patent Division of the United States Patent and Trademark Office on June 29, 2010 at Reel 024599, Frame 0921; and

WHEREAS, Grantor has requested that Agent release its security interest in the Patents and Patent Rights and reassign the same to Grantor. Capitalized terms used herein without definition are used as defined in the Agreement.

NOW THEREFORE, for good and valuable consideration, receipt and sufficiency of which are hereby acknowledged:

1. Agent hereby releases its security interest in all of Grantor’s right, title and interest in and to the following (collectively the “**Patent Rights**”):

- (i) all of its Patents and all IP Licenses providing for the grant by or to such Grantor of any right under any Patent, including, without limitation, those referred to on Schedule 1 hereto;
- (ii) all renewals and extensions of the foregoing;
- (iii) all goodwill of the business connected with the use of, and symbolized by, each such Patent; and
- (iv) all income, royalties, proceeds and Liabilities at any time due or payable or asserted under and with respect to any of the foregoing, including, without limitation, all rights to sue and recover at law or in equity for any past, present and future infringement, misappropriation, dilution, violation or other impairment thereof.

2. Agent hereby reassigns, grants and conveys to Grantor, without any representation, recourse or undertaking by Agent, all of Agent's right, title and interest in and to the Patents and the Patent Rights.
