MI4Spine further agrees, upon the request of Thompson MIS, its successors and assigns, to cooperate to the best of the ability of MI4Spine with Thompson MIS, its successors and assigns, in any proceedings or transactions involving such applications or patents, and to require its employees, officers, representatives, and/or agents to do the same. Such proceedings include the preparation and execution of preliminary statements, giving and producing evidence, and

performing any and all other acts necessary to obtain, maintain, or to enforce the Assigned Intellectual Property and said Letters Patent, both United States and foreign, and vest all rights therein hereby conveyed in Thompson MIS, its successors and assigns. MI4Spine agrees that the Assigned Intellectual Property and said Letters Patent will be held and enjoyed by Thompson MIS, its successors and assigns, to the full end of the term for which said Assigned Intellectual Property and said Letters Patent have been or will be granted, as fully and entirely as the same would have been held and enjoyed by MI4Spine if this assignment had not been made.
