

attorney and other instruments that said Thermwood Corporation, may consider necessary or advisable to secure letters patents of the United States of America for said invention, and any continuations, continuations-in-part, divisions, reissues, extensions and renewals thereof, and to vest and confirm in said Thermwood Corporation, the full and complete legal and equitable title to said invention, application and letters patents, without further consideration than that now paid but at the expense of said Thermwood Corporation.
