THIS DEED is made on the 12th day of October 2010
BETWEEN:

- (1) **The Science and Technology Facilities Council**, a company incorporated by Royal Charter in England and Wales with registered number RC000817 whose principal place of business is at Polaris House, North Star Avenue, Swindon, SN2 1SZ ("STFC"); and
- (2) **Microvisk Limited**, a company incorporated in England and Wales with company number 05035044 whose registered office is at Innovation House, St Asaph Business Park, St Asaph, Denbighshire, LL17 0LJ ("Microvisk").

BACKGROUND

- (A) STFC is the proprietor of the Patents and the Intellectual Property Rights.
- (B) Pursuant to a deed dated the same date as this Deed ("the Transfer Agreement") STFC has agreed to assign the Patents and the Intellectual Property Rights (as defined in the Transfer Agreement).

OPERATIVE PROVISIONS

1. Interpretation

1.1. In this Deed the following defined terms have the meanings set out below:

Patents	means the patents and patent applications listed in Schedule 1 to this Deed and all existing or future patents and patent applications that may derive priority from or are based upon these in any country of the world (and including supplementary protection certificates, divisions, continuations, continuations in part, reissues, and extensions);

- 1.2. Clause headings do not affect the interpretation of this Deed.
- 1.3. Writing or written includes faxes but not e-mail.
- 1.4. Words in the singular include the plural and in the plural include the singular.

2. Assignment

- 2.1. Pursuant to the Transfer Agreement and in consideration the payment of £1 made by Microvisk to STFC (receipt of which STFC hereby acknowledges) STFC hereby assigns to Microvisk with full title guarantee all of its right, title and interest in and to the Patents and the Intellectual Property Rights including without limitation:
 - 2.1.1. the right to recover and take all such proceedings as may be necessary for the recovery of damages or otherwise in respect of all infringements of any of the Patents and/or the Intellectual Property Rights, whether committed before, on, or after the date of this Deed and

- 2.1.2. the right to apply for, prosecute and obtain patent or similar protection in all other countries of the world for an invention embodied by any of the Patents, including the right to claim priority from such Patents,

(together the "**Rights**").

At the request and expense of Microvisk, STFC will do all acts including executing all such documents as may reasonably be required by Microvisk (including without limitation providing all reasonable assistance in registering the assignment at the relevant patent offices which will primarily be the responsibility of Microvisk) to assign to Microvisk all of its right, title, and interest in and to the Rights. For the avoidance of doubt Microvisk shall have the responsibility for recording the assignment at the relevant patent office if it so chooses.

- 2.2. Microvisk hereby accepts the assignment to it at clause 2.1
- 2.3. This Deed and any disputes or claims arising out of or in connection with it or its subject matter or formation (including non-contractual disputes or claims) are governed by and construed in accordance with the law of England. The parties irrevocably agree that the courts of England have jurisdiction to settle any dispute or claim that arises out of or in connection with this Deed or its subject matter or formation (including non-contractual disputes or claims).

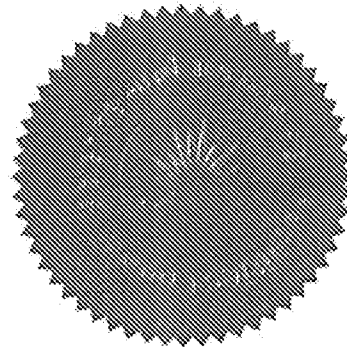
