ASSIGNMENT

WHEREAS, we, Wayne H. Rothschild and Kevin McComb, have invented certain new and useful improvements in the following:

CONVERTIBLE STORAGE CONTAINER

for which we have made application for United States Letters Patent, the application having been filed on **September 20, 2011**, as Application No. **13/237,224**;

We further agree to execute any and all powers of attorney, applications, assignments, declarations, affidavits, and any other papers in connection therewith necessary to perfect such rights, title, and interest in ASSIGNEE, its successors, assigns, and legal representatives.

We hereby further agree that we will communicate to said ASSIGNEE, or its successors, assigns, and legal representatives, any facts known to us respecting any improvements; and, at the expense of said ASSIGNEE, to testify in any legal proceedings, sign all lawful papers, execute all provisional, utility, design, divisional, continuation, continuation-in-part, reissue, and substitute applications, make all lawful oaths, and generally do everything possible to vest title in said ASSIGNEE and to aid said ASSIGNEE, its successors, assigns, and legal representatives to obtain and enforce proper protection for said invention in all countries.
