And I do hereby request and authorize the United States Commissioner of Patents and Trademarks to issue all said Letters Patent, when granted, in accordance with the terms of this assignment.

I further covenant and agree with the Assignee that I have full and unencumbered title to the invention and patent application herein assigned, which title I warrant unto the Assignee, and I further agree that, when requested, I will, without demanding any further consideration therefor but at the expense of Assignee, do all lawful and just acts, including the execution and acknowledgement of instruments, that may be or become necessary for obtaining, sustaining or reissuing United States Letters Patent for the said invention and patent application, and for maintaining and perfecting the Assignee's right to said invention, patent application and Letters Patent particularly in cases of interference and litigation.




