**Second Amendment
To
Patent Purchase Agreement**

This Second Amendment ("**Amendment**") is entered into as of ~~November~~ ^{December} 2011, ("**Second Amendment Effective Date**") by and between Korishima Property LLC, a Delaware limited liability company, with an address at 160 Greentree Drive, Suite 101, Dover, DE 19904 ("**Purchaser**") and International Game Technology, a Nevada corporation with an office at 9295 Prototype Drive, Reno, NV 89521 ("**Seller**"). The parties hereby agree as follows:

1. Background

- 1.1 Seller and Purchaser entered into a Patent Purchase Agreement with an Effective Date of August 23, 2011 and First Amendment to the Patent Purchase Agreement with an Amendment Effective Date of September 22, 2011 (collectively, the "**Agreements**").
- 1.2 Seller's name was stated as "International Game Technology" in the Agreements but the correct name should have been "IGT".
- 1.3 Seller and Purchaser desire to amend the Agreement pursuant the terms and conditions of this Amendment.

2. Terms Used in This Amendment

Capitalized terms used in this Amendment shall have the same meanings set forth in the Agreement, unless stated otherwise herein.

3. Amendments to Agreement

- 3.1 Every instance in the Agreements where it says "International Game Technology" shall be changed to read "IGT".
- 3.2 Exhibits B and C are deleted in their entirety and replaced with the attached Exhibits B and C.

4. No Other Changes

This Amendment amends and supersedes the Agreement and all prior amendments with respect to the subject matter of this Amendment, and supersedes all prior and contemporaneous negotiations and other writings with respect to such matters. In the event that a conflict arises between this Amendment and the Agreement or a prior amendment, this Amendment shall control. Except for the changes made herein, the terms and conditions of the Agreement and its Exhibits shall remain unchanged and in full force and effect.

5. Governing Law

This Amendment will be interpreted, construed, and enforced in all respects in accordance with the laws of the State of Delaware, without reference to its choice of law principles to the contrary.

6. Counterparts; Electronic Signature

This Amendment may be executed in counterparts, each of which will be deemed an original, and all of which together constitute one and the same instrument. Each party

will execute and promptly deliver to the other parties a copy of this Amendment bearing the original signature. Prior to such delivery, in order to expedite the process of entering into this Amendment, the parties acknowledge that a Transmitted Copy of this version will be deemed an original document. **"Transmitted Copy"** means a copy bearing a signature of a party that is reproduced or transmitted via email of a .pdf file, photocopy, facsimile, or other process of complete and accurate reproduction and transmission.



Assignor has obtained and properly recorded previously executed assignments for the Patent Rights as necessary to fully perfect its rights and title therein in accordance with governing law and regulations in each respective jurisdiction. The Patent Rights are free and clear of all liens, claims, mortgages, security interests or other encumbrances, and restrictions. To the best knowledge of Seller following reasonable due diligence and investigation, there are no actions, suits, investigations, claims or proceedings threatened, pending or in progress relating in any way to the Patent Rights. To the best knowledge of Seller following reasonable due diligence and investigation, there are no existing contracts, agreements, options, commitments, proposals, bids, offers, or rights with, to, or in any person to acquire any of the Patent Rights.

Assignor hereby authorizes the respective patent office or governmental agency in each jurisdiction to issue any and all patents, certificates of invention, utility models or other governmental grants or issuances that may be granted upon any of the Patent Rights in the name of Assignee, as the assignee to the entire interest therein.

Assignor will, at the reasonable request of Assignee and without demanding any further consideration therefore, do all things necessary, proper, or advisable, including without limitation, the execution, acknowledgment, and recordation of specific assignments, oaths, declarations, and other documents on a country-by-country basis, to assist Assignee in obtaining, perfecting, sustaining, and/or enforcing the Patent Rights.

The terms and conditions of this Assignment of Patent Rights will inure to the benefit of Assignee, its successors, assigns, and other legal representatives and will be binding upon Assignor, its successors, assigns, and other legal representatives.
