Animal Flotation Vest with Shark Fin Decoration

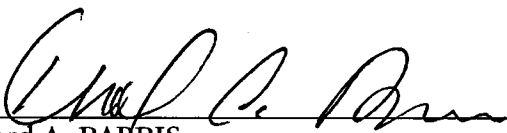
