EXHIBIT A

PATENT ASSIGNMENT AGREEMENT

WHEREAS MedicineLodge, Inc. d/b/a IMDS, located at 124 South 600 West, Logan, Utah, 84321 (hereinafter, "Seller") is the sole and exclusive owner of certain United States or foreign patents or patent applications listed in Exhibit A-1 annexed hereto (collectively referred to as the "Patent Rights"); and

For good and valuable consideration, the receipt of which is hereby acknowledged, Seller does hereby sell, assign, transfer and set over to Purchaser, the Patent Rights aforesaid, any reissue or reissues of said Patent Rights already granted and which may be granted, any certificates of reexamination already granted and which may be granted the same to be held and enjoyed by Purchaser for its own use and enjoyment, and for the use and enjoyment of its successors, assigns or other legal representatives, to the end of the term or terms for which said Patent Rights are or may be granted, reissued or extended as fully and entirely as the same would have been held and enjoyed by Seller, if this assignment and sale had not been made; together with all claims for damages by reason of past, current, and future infringement or provisional rights under said Patent Rights, with the right to sue for, and collect the same for its own use and behalf, and for the use and behalf of its successors, assigns or other legal representatives.

And, Seller, hereby authorizes and requests the Commissioner of Patent Rights and Trademarks to issue any and all Letters Patent Rights of the United States corresponding to the Patent Rights aforesaid to Purchaser as assignee of the entire interest, and hereby covenants that Seller has full right to convey the entire interest herein assigned, and that, except as otherwise provided between the parties, Seller has not executed, and will not execute, any agreements in conflict therewith.

And Seller hereby grants Purchaser the right to file and prosecute any application claiming priority to the Patent Rights in non-United States countries in Purchasers name.



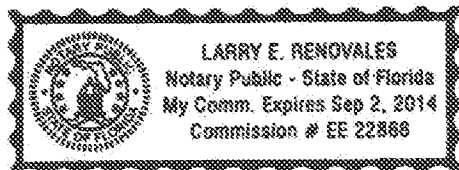
