SELL, ASSIGN AND TRANSFER to OTTO BOCK HEALTHCARE GMBH ("ASSIGNEE"), a foreign corporation, having a place of business at Max-Näder-Strasse 15, Duderstadt, Germany 37115, the entire right, title and interest for the United States and all foreign countries in and to any and all improvements which are disclosed in PCT International Application No. PCT/EP2010/000540 filed on 29 January 2010, for which a U.S. application was filed under 35 USC 111 on 29 July 2011, as United States application serial no. 13/194,264, and entitled USE OF FINELY DISPERSED METAL PARTICLES IN A MATERIAL, A SKIN PATCH AND AN ORTHOPEDIC ARTICLE, such application and all divisional, continuing, substitute, renewal, reissue and all other applications for patent or the legal equivalent thereof which have been or may be filed in the United States and all foreign countries relating to any of such improvements; all original, reexamined and reissued patents which have been or shall be issued in the United States and all foreign countries on such improvements; and specifically including the right to file foreign applications under the provisions of any convention or treaty and claim priority based on such application made in the United States;

AUTHORIZE AND REQUEST the issuing authority to issue any and all United States and foreign patents granted on such improvements to and in the name of the ASSIGNEE;


