**TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT**

**THIS TERMINATION AND RELEASE OF PATENT SECURITY AGREEMENT** (this "Termination"), is dated as of October [31], 2011, and made by BANK OF THE WEST, having an office at 1280 4th Avenue, San Diego, California 92101 ("Grantee") to PACIFIC WORLD CORPORATION, ("Grantor"), with its chief executive office at 25800 Commercentre Drive, Lake Forest, California 92630.

WHEREAS, pursuant to that certain Patent Security Agreement dated as of May 25, 2010, made by Grantor in favor of Grantee (the "Security Agreement"), a security interest was granted by the Grantor to Grantee in certain collateral, including the Patents (as hereinafter defined);

WHEREAS, the Security Agreement was recorded in the Patent Division of the United States Patent and Trademark Office on June 11, 2010, at Reel 024515 and Frame 0719; and

WHEREAS, Grantee now desires to terminate and release the Security Agreement;

NOW, THEREFORE, for good and valuable consideration, the receipt and adequacy of which are hereby acknowledged, and upon the terms set forth in this Termination, Grantee hereby states as follows:

1. Definitions. The term "Patents," as used herein, shall mean all of the Grantor's right, title and interest of every kind and nature as of the date hereof in the patents listed on Schedule A hereto.

2. Release of Security Interest. Grantee hereby terminates the Security Agreement and terminates, releases and discharges its security interest in the Patents and reassigns to the person or persons legally entitled thereto all right, title and interest of Grantee in the Patents.
