ASSIGNMENT

WHEREAS, Arturo Perez-Medrano of Grayslake, IL 60030, Sridhar Peddi of Grayslake, IL 60030, and David DeGoey of Salem, WI 53168; hereinafter called the "Assignors", have made the invention described in the United States patent application entitled "POTASSIUM CHANNEL MODULATORS" that has a U.S. Patent Application Serial Number of 13/287,647 and was filed on November 2, 2011;




