Assignment of Invention

WHEREAS WE, **Shingo OKUBO, Kazutaka YANAGITA, Julien GATINEAU, and Mao MINOURA**, respectively, have invented certain new and useful improvements in "Tellurium Precursors for Film Deposition" for which an application for Letters Patent was filed May 29, 2009, having Application No. 12/475,204;

WHEREAS **L'Air Liquide, Société Anonyme pour l'Etude et l'Exploitation des Procédés Georges Claude**, a French corporation having offices at 75 Quai d'Orsay, F-75007 Paris, France, hereinafter referred to as "ASSIGNEE," desires to acquire from **Mao MINOURA** the entire right, title, and interest I have in and to said invention, and in and to any Letters Patent that may be granted thereof in the United States and its territorial possessions and in any and all foreign countries;

Further, I agree that I will communicate to said ASSIGNEE or its representatives any facts known to me respecting said invention, and testify in any legal proceeding, sign all lawful papers, execute all non-provisional, divisional, continuation, substitute, renewal and reissue applications, execute all necessary assignment papers to cause any and all of said Letters Patent to be issued to said ASSIGNEE, make all rightful oaths, and, generally do everything possible to aid said ASSIGNEE, its successors and assigns, to obtain and enforce proper protection for said invention in the United States and its territorial possessions.

The undersigned hereby grants authorized representatives of the above identified ASSIGNEE the power to insert on this assignment any further identification which may be necessary or desirable in order to comply with the rules of the United States Patent and Trademark Office for recordation of this document.
