ASSIGNMENT

enjoyment of this grant, and render all necessary assistance in making application for and obtaining original, divisional, continuation, continuation-in-part, reexamined, reissued, or extended Letters Patent of the United States or of any and all foreign countries claiming said invention, and in enforcing any rights or choses in action accruing as a result of such applications or patents, by giving testimony in any proceedings or transactions involving such applications or patents, and by executing preliminary statements and other affidavits, it being understood that the foregoing covenant and agreement shall bind, and inure to the benefit of, the assigns and legal representatives of ASSIGNOR and ASSIGNEE;

AND it is requested that the Commissioner of Patents and Trademarks or the corresponding official in any foreign country in which a patent or patents may issue claiming said invention to issue said patent or patents jointly to **THE UNIVERSITY OF KENTUCKY RESEARCH FOUNDATION** and **THE CURATORS OF THE UNIVERSITY OF MISSOURI**, their legal representatives, successors or assigns, as the joint owners of the entire right, title and interest in and to said patents and the inventions covered thereby.
