FUEL SYSTEM CENTRIFUGAL BOOST PUMP IMPELLER

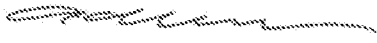

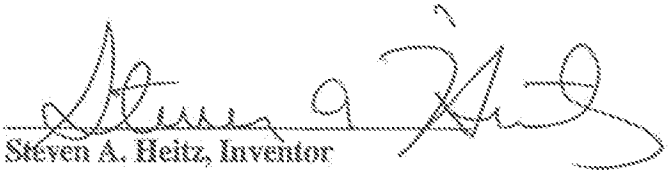
