The Assignor covenants that it will promptly execute and deliver all documents, papers, forms and authorizations which may be necessary for securing, completing or absolutely vesting full rights, title and interest in and to the Design, in favour of the Assignee.


This Agreement may be executed in one or more counterparts, each of which shall be deemed an original, but all of which together shall constitute one and the same instrument.
