ASSIGNORS hereby agree to execute any papers, provide any information and testify in any interference or litigation at the request of ASSIGNEES, their successors, assigns and legal representatives, when deemed essential to ASSIGNEES', their successors', assigns' and legal representatives' full enjoyment, protection, enforcement and title in and to such invention and rights hereby transferred.

ASSIGNORS furthermore agree upon request of said ASSIGNEES, their successors, assigns and legal representatives, and without further remuneration, to execute any and all papers desired by said ASSIGNEES, their successors, assigns and legal representatives, for the filing and granting of foreign applications and the perfecting of title thereto in said ASSIGNEES, their successors, assigns and legal representatives.




