## ASSIGNMENT

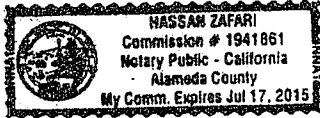

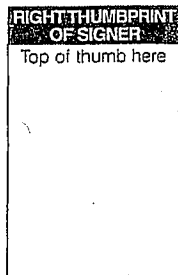

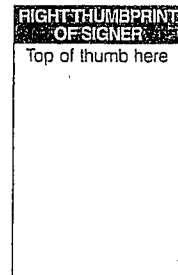
