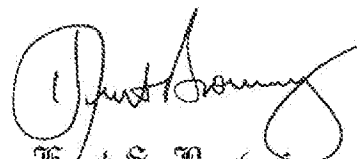

Pursuant to Section 607.1006 of the Florida Business Corporation Act, Pegasus Imaging Corporation (the "Corporation"), a corporation organized and existing under the Florida Business Corporation Act,

DOES HEREBY CERTIFY:
