ASSIGNMENT

WHEREAS, I, Elisabeth Hildegard
Billes Pieper, the executor of the estate of **Herbert Pieper**, do hereby state that:

Herbert Pieper invented certain new and useful compositions, methods, devices, and/or systems for which a United States Patent application entitled "**Sound insulating element and process for producing a sound insulating element**" was filed under Serial No. 13/319,979 on November 10, 2011, which application claims the benefit of German patent application no. 10 2009 020 963.8, as filed on May 12, 2009, and which is a national stage application from International Application No. PCT/EP2010/002897, (U.S. patent application serial no. 13/319,979 and the priority application and international application being collectively referred to "Application"); and

WHEREAS, **ROCKWOOL INTERNATIONAL A/S**, a corporation, having its principal place of business located at Hovedgaden 584, 2640 Hedehusene, Denmark, is desirous of acquiring the entire right, title and interest in and to Application and all inventions set forth therein and all right, title and interest in, to and under any and all patents granted thereon and other forms of legal protection thereto in the United States;

NOW, THEREFORE, for and in consideration of the sum of One Dollar (\$1.00) and for other good and valuable consideration, the receipt of which is hereby acknowledged, I, as the executor of the estate of Herbert Pieper, sell, assign, transfer and set over to **ROCKWOOL INTERNATIONAL A/S**, all right, title and interest in and to Application, and any and all divisions, continuations, reexaminations and reissues thereof, and any and all applications which claim priority to Application as well as all patents of the United States which may be granted therefrom including any reissues, divisionals, continuations, renewals and extensions and the like (collectively, the "Patents"), the same to be held and enjoyed by **ROCKWOOL INTERNATIONAL A/S** for its own use and benefit, and for the use and benefit of its successors, assigns, or other legal representatives, to the end of the term or terms for which said Patents of the United States are or may be granted or reissued, as fully and entirely as the same would have been held and enjoyed by me if this assignment and sale had not been made.

And I hereby authorize and request the Commissioner of Patents to issue any and all patents on said invention or resulting from said Application and from any and all divisionals, continuations, reissues, reexaminations, renewals, and extensions thereof, to **ROCKWOOL INTERNATIONAL A/S**, as assignee of my entire interest, and hereby covenant that I have the full right to convey the entire interest herein assigned, and that I have not executed and will not execute any agreement in conflict herewith.

And I further hereby covenant and agree that I will, at any time, upon request, execute and deliver any and all papers that may be necessary or desirable to perfect the title of said invention and to such patents as may be granted therefor, to **ROCKWOOL INTERNATIONAL A/S**, its successors, assigns, or other legal representatives and that if

ROCKWOOL INTERNATIONAL A/S, its successors, assigns or other legal representatives shall desire to file any divisional or continuation, or to secure a reissue, or reexamination of such patents, or to file a disclaimer relating thereto, will upon request, sign all papers, make all rightful oaths and do all lawful acts requisite for the filing of such divisional or continuation applications, or such application for reissue or reexamination and the procuring thereof, and for the filing of such disclaimer, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

And I do further covenant and agree that I will, at any time upon request, communicate to **ROCKWOOL INTERNATIONAL A/S**, its successors, assigns or other legal representatives, such facts relating to said invention and patents or the file history thereof as may be known to me, and testify as to the same in any interference or other litigation when requested so to do, without further compensation but at the expense of said assignee, its successors, or other legal representatives.

As the executor of the estate of Herbert Pieper, I hereby affirm that I have the legal capacity to make this Assignment and to undertake this obligation of Herbert Pieper to **ROCKWOOL INTERNATIONAL A/S**.
