## INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE

This INTELLECTUAL PROPERTY SECURITY AGREEMENT RELEASE (the “*Release*”), dated January 13, 2012, is made by Bank of America, N.A., as collateral agent (the “*Collateral Agent*”) for the Secured Parties, in favor of the Persons listed in Schedule A attached hereto (collectively, the “*Grantors*”). All capitalized terms used herein and not otherwise defined shall have the meaning assigned to such terms in the Credit Agreement (as defined below).

WHEREAS, the Grantors entered into that certain Credit Agreement, dated as of May 13, 2008 and as amended as of February 14, 2011 (the “*Credit Agreement*”), with the Collateral Agent and the lender and other Persons parties party thereto;

WHEREAS, pursuant to that certain Intellectual Property Security Agreement (as amended, amended and restated, supplemented or otherwise modified from time to time, the “*IP Security Agreement*”), dated May 30, 2008, the Grantors granted to the Collateral Agent for the ratable benefit of the Secured Parties a security interest in and to certain intellectual property of the Grantors;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on May 22, 2008 at Reel 020986 and Frame 0285, with respect to U.S. patents and patent applications;

WHEREAS, the IP Security Agreement was recorded with the United States Patent and Trademark Office on May 22, 2008, at Reel 003781 and Frame 0975, with respect to U.S. trademarks and trademark applications; and

WHEREAS, in accordance with the provisions of the Credit Agreement and the IP Security Agreement, the Collateral Agent now desires to release its security interest in and to the Collateral (as defined below).

NOW, THEREFORE, for good and valuable consideration, the receipt and sufficiency of which are hereby acknowledged, the Collateral Agent hereby agrees as follows:

SECTION 1. Release of Grant of Security. The Collateral Agent hereby terminates, releases, and discharges any security interest in the following Collateral (as defined below) granted to Collateral Agent pursuant to the IP Security Agreement, and assigns, transfers, and conveys to the Grantors any right, title and interest in and to the following Collateral that Collateral Agent may hold, all without warranty or representation of any kind:

- (i) the patents and patent applications set forth in Schedule B attached hereto (the “*Patents*”);
- (ii) the trademark and servicemark registrations and applications set forth in Schedule C attached hereto, together with the goodwill symbolized thereby (the “*Trademarks*”);

(iii) all copyrights, whether registered or unregistered, including, without limitation, the copyright registrations and applications and exclusive copyright licenses set forth in Schedule D attached hereto (the “*Copyrights*”);

(iv) all reissues, divisions, continuations, continuations-in-part, extensions, renewals and reexaminations of any of the foregoing, all rights in the foregoing provided by international treaties or conventions, all rights corresponding thereto throughout the world and all other rights of any kind whatsoever of such Grantor accruing thereunder or pertaining thereto;

(v) any and all claims for damages and injunctive relief for past, present and future infringement, dilution, misappropriation, violation, misuse or breach with respect to any of the foregoing, with the right, but not the obligation, to sue for and collect, or otherwise recover, such damages; and

(vi) any and all proceeds of, collateral for, income, royalties and other payments now or hereafter due and payable with respect to, and supporting obligations relating to, any and all of the Collateral of or arising from any of the foregoing. (Collectively (i) through (vi), the “*Collateral*”.)

SECTION 2. Collateral Agent agrees to take such further action as may be reasonably requested by Grantors, from time to time, at Grantors’ expense, to effectuate and carry out the provision and intent of this Release.


