## UNITED STATES DESIGN PATENT ASSIGNMENT

own use and enjoyment, to the end of the term or terms of the patent, and any and all other patents as may be granted on the Patent Application or on any other application claiming any right of priority to any or all of the Patent Applications, as fully and entirely as the same would have been held and enjoyed by Assignor if this sale, assignment, transfer and conveyance had not been made; together with and including without limitation any and all claims for damages by reason of past infringement of any such patent, with the right to sue for and collect the same for the sole and exclusive use and benefit of Assignee, its successors and assigns.

AND, FURTHER, Assignor represents and warrants to Assignee that he has full right to convey the interest herein assigned, and has not executed, and will not execute, any assignments or agreements inconsistent herewith.
