ASSIGNMENT

WHEREAS I/We, HAGINO, JUNICHI ; HARUTA, SHINGO (hereinafter referred to as "ASSIGNOR") of c/o ROHM CO., LTD., 21, Saiin Mizosaki-cho, Ukyo-ku, Kyoto 615-8585, Japan have invented certain new and useful improvements in:

**DRIVE CIRCUIT FOR LIGHT-EMITTING DIODE, AND LIGHT-EMITTING DEVICE AND ELECTRONIC DEVICE USING THE SAME**

which claims priority to Japan Application No. 2011-014403, filed Jan. 26, 2011 and for which I am about to file or have filed an application for Letters Patent of the United States;
