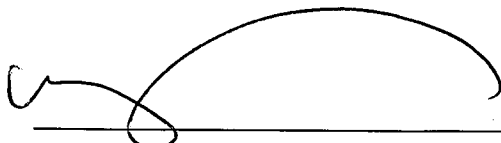
ASSIGNMENT
