## ASSIGNMENT

Donald E. Labbe, residing at 6 Loker Lane, Woburn, MA 01801; Alan Morrow, residing at 5 Spring House Lane, Cumberland, RI 02864, Andrew Speziale, residing at 1 Jacob Drive, Mansfield, MA 02048 and Thomas Kinney residing at 2 Odyssey Lane, Franklin, MA 02038 (each referred to as "Assignor") have made an invention(s) (the "Invention(s)") set forth in an application for patent of the United States, entitled **SMART FIRING CONTROL IN A RANKINE CYCLE POWER PLANT**, and which is a:

- (d) any application(s) for patent of the United States or other countries claiming the Invention(s);

(e) any application(s) for patent of the United States or other countries claiming priority to the application for patent identified in paragraph (1) or (2) or any application(s) for patent claiming the Invention(s), including any division(s), continuation(s), and continuation(s)-in-part; and

(f) any provisional or other right to recover damages, including royalties, for prior infringements of any application for patent identified in the preceding paragraphs (b)-(e); and

(g) any patent(s) of the United States or other countries that may be granted for or on any application for patent identified in the preceding paragraphs (b) – (e), including any reissue(s) and extension(s) of said patent(s).

The above-granted rights, titles, and interests are to be held and enjoyed by the Assignee, for its own use and behalf and the use and behalf of its successors, legal representatives, and assigns, as fully and entirely as the same would have been held and enjoyed by the Assignor had this sale and assignment not been made.
